AN ACT TO AMEND THE CONSTITUTION OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

BE it enacted by the Parliament of the Democratic Socialist

1. This Act may be cited as the Twentieth Amendment to Short title. the Constitution.

2. The following new Article is hereby inserted Insertion of new 5 immediately after Article 154D of the Constitution of the Article 154DD Democratic Socialist Republic of Sri Lanka (hereinafter ^{in the} Constitution of referred to as the "Constitution") and shall have effect as the Democratic Article 154DD of the Constitution:-Socialist Republic of

Sri Lanka. 10 "Election of 154DD. The election of members to all Provincial Provincial Councils shall be held on the same Councils. date and the Parliament shall determine the date on which all the Provincial Councils shall stand dissolved (in this Chapter referred to as the "specified date"): 15

> Provided that, such specified date shall not be later than the expiration of the term of the last constituted Provincial Council.".

3. Article 154E of the Constitution is hereby amended Amendment of 20 by the substitution for the words "as a dissolution of the $\frac{\text{Article 154E of}}{\text{the}}$ the Council." of the following:-

Provided, however, upon the determination of the specified date under Article 154DD-

to be extended up to the specified date and such Provincial Council shall stand dissolved on the specified date; or

(b) the term of office of any Provincial Council which continues beyond the specified date shall end on the specified date and such Provincial Council shall stand dissolved on the specified date.".
