Whereas the Cabinet of Ministers by its decision dated 27th July, 2011 approved among other things:—

- (a) Investment of USD 520.0 million in the equity capital over a five year period to SriLankan and Mihin Lanka Airlines commencing year 2012;
- (b) Allocation of above funds under the annual national budget estimates commencing year 2012; and
- (c) Authorized the Treasury to issue a sovereign guarantee of USD 270 million immediately in order to obtain bridging finance facilities from local/foreign banks or financial institutions.

And whereas subsequent to the above approval SriLankan Airlines had initiated the fleet renewal process in the year 2012 in terms of the business plan prepared by them;

And whereas SriLankan Airlines had carried out negotiations with Airbus, Boeing, Rolls Royce and General Electric and after the conclusion of the negotiations with the manufactures and a decision was made to purchase six (06) A330-300 aircraft with Trent 700 engines and four (04) A350-900 aircraft with Trent XWB engines directly from Airbus;

And whereas a decision was also made to source additional three (03) A350-900 aircraft on lease to be delivered in 2017;

And whereas a decision, had been made on the basis of seeking approval of the Cabinet of Ministers for the replacement exercise;

And whereas consequently SriLankan Airlines entered into a Memorandum of Understanding with Airbus and Rolls Royce before 31 March 2013 to secure slots for delivery in 2020 for the A350-900 aircraft;

And whereas in April 2013 at a meeting between the Secretary to the Treasury, Secretary, Ministry of Civil Aviation, Chairman and Chief Executive of SriLankan Airlines and officials of the Treasury, the Secretary to the Treasury who chaired the meeting had expressed the view that SriLankan Airlines as a Public Limited Liability Company is required to conduct its business in accordance with the Board approved business plan;

And whereas subsequently, SriLankan Airlines had signed a Memorandum of Understanding with Airbus to purchase A350 aircraft followed by signing the Purchase Agreement relating to the A350-900 aircraft in June 2013;

And whereas SriLankan Airlines had then decided to source another A350-900 aircraft in September 2014 considering the aircraft requirement beyond 2015 and planned new routes, and accordingly, the number of total A350-900 aircraft in SriLankan Airline's fleet had increased to eight (08);

And whereas SriLankan Airlines had carried out a selection process by inviting proposals from aircraft lessors in leasing this aircraft and AetCap had eventually been selected to lease the aircraft;

And whereas the A350-900 aircraft can fly up to 17 hours makes it the longest range aircraft in the world;

And whereas both the purchase and rental amounts undertaken by Sri Lanka significantly above current market values;

And whereas it had turned out that none of these aircraft could be operated profitably by Sri Lanka;

And whereas the decisions taken by the then management of SriLankan Airlines resulted in enormous losses to the Airlines as well as the country;

That this Parliament resolves that a Select Committee of Parliament be appointed to inquire and report on whether—

- (a) the, then management had acted in total disregarding government approved procurement procedures;
- (b) the purchase of the aircraft as set out above was an ill considered decision in the light of the prevailing market conditions;
- (c) the actions of the then management had caused losses to SriLankan Airlines and if so, in what sums;
- (d) any individual or individuals could be held responsible for these losses;
- (e) any person or persons and institutions had received any, kickbacks from these transactions, and if who;
- (f) what action should be taken against any person or persons found guilty of deliberate violation of government approved procurement procedure and receiving kickbacks; and
- (g) any other matter the Committee finds is relevant to their inquiries.
- 2. (a) That the Committee and its Chairman shall be nominated by Mr. Speaker;
 - (b) That notwithstanding the provisions of Standing Order No. 95 of the Parliament, the Committee shall consist of not more than twenty one (21) Members.
- 3. That the Committee shall have the power to:
 - (a) fix its quorum;
 - (b) send for persons, papers and records, may order any person to attend before Parliament or before such Committee, and to produce any paper, book, record or document in the possession or under the control of such person;
 - (c) verify or otherwise ascertain by the oral examination of witnesses and examine witnesses upon oath or affirmation which the Chairman of the Committee or a person specially authorized for that purpose may administer;
 - (d) obtain the services of Specialists and Experts in the relevant fields to assist the Committee; and
 - (e) make interim reports from time to time and to sit notwithstanding any adjournment of Parliament.
- 4. That the Committee shall make its Report within Six Months (06) of the date of its first sitting or such other or further time as Parliament may grant.
