- (d) And whereas continue to pay to the ex-officio Members an allowance of Rs.10,000/- for attending a meeting of the Commission in terms of the provisions of the Public Enterprises Circular No. 03/2015, dated 17.06.2015;
- (e) And whereas since the powers have been delegated equally to the Chairperson and Members of the Commission to Investigate Allegations of Bribery or Corruptions under Section 8 of the Commission to Investigate Allegations of Bribery or Corruption Act, No. 19, of 1994, increase the monthly allowance of Rs. 95,000/- paid at present to the Members to Rs. 130,000/- and to continue to pay the other allowances paid in addition at present unchanged; and
- (f) pay to the Chairperson and Members of the Election Commission a special allowance equivalent to ³/₄ of their monthly allowance during the period from the day an election is declared to the day the results of that election is announced;
